**TERMS AND CONDITIONS OF ENROLMENT**

I, the student whose name appears below, hereby agree to enrol as a student at the Byron Bay English Language School on the following terms and conditions:

- I agree to waive and release all claims against Byron Bay English Language School Pty Ltd (BBELS) , its directors and its appointed agents for any loss, injury, accident, delay or expense resulting from participation in any of its courses, airport transfers and all accommodation arrangements. I also release BBELS, its directors and its appointed agents and agree to indemnify BBELS, its directors and its appointed agents with regard to any financial obligations or liabilities that I may personally incur or any damage or injury to the person or property of others that I may cause while enrolled in BBELS courses.
- I understand that BBELS, its directors and appointed agents are not responsible for injury or loss suffered by me during periods of independent travel or absence from the enrolled courses.
- If I become ill, injured, or incapacitated, BBELS, its directors, teachers, appointed agents and Homestay or farmstay family members may take such action as any of them considers necessary, including securing medical treatment for me and transporting me back to my country at my own expense. I release them from all liability related to such actions.
- I understand that my participation in BBELS programs may be terminated at the discretion of BBELS, its owners and its appointed agents without refund of fees and that I may be sent home at my own expense if I do not adhere to BBELS rules, standards and instructions.
- I agree that the laws of Australia shall apply to this agreement and I agree to submit to the jurisdiction of the Australian law.
- BBELS reserves the right to expel students for serious breaches of discipline. Fees will not be refunded in such cases.
- I agree to allow BBELS to provide my personal information to Commonwealth and State agencies and the ESOS Assurance Fund Manager should it be required to do so.

**CANCELLATION, POSTPONEMENT & REFUND POLICY**

- If your visa application is rejected, tuition and accommodation fees will be refunded in full less the registration and accommodation placement fee. Evidence of the Australian Embassy visa rejection letter must be made available to BBELS.
- Registration and accommodation placement fees are non-refundable in all instances.
- If a student cancels 28 days or more before the course begins, all tuition and accommodation fees will be refunded, excluding the registration and accommodation placement fees. Refund will be paid within 4 weeks of cancellation notice date less any bank transfer fees incurred by BBELS.
- If notice of cancellation is received less than 28 days before the commencement date of your course, tuition will be refunded less 4 weeks course fees, accommodation fees less 2 weekly accommodation payments, registration and accommodation placement fees. Payment will be made within 4 weeks of cancellation notice date less any bank transfer fees incurred by BBELS.
- Notice to BBELS of any postponement (delayed start date) of accommodation services (homestay, student or share house) must be received 14 days before the accommodation start date. If notice of postponement is received less than 14 days before the commencement date of your course, 2 weeks accommodation fees will be charged.
- No refund is payable after you have commenced studying at BBELS. Accommodation refunds can be made with minimum 2 weeks notice, subject to BBELS management discretion.
- Course fees are not transferable to another person or institution.
- In the unlikely circumstance that BBELS must cancel a course, all tuition fees and compulsory course fees plus any unused accommodation fees at the cancellation date will be refunded in full. Reimbursement is 2 weeks from the date of notice of cancellation/default. As an alternative to making a payment, BBELS may arrange for another course, or part of a course, to be provided to the student at BBELS expense. If the student accepts this arrangement, BBELS will be relieved of its liability to make this payment.
- Applications for refunds must be directed in writing to BBELS in Australia or its appointed agents in a student's home country within 28 days of a refund becoming applicable.
- This agreement/ policy does not remove the right to take further action under Australia's consumer protection laws. The student's right to pursue other legal remedies are not circumscribed by the BBELS dispute resolution process. Students have the right to appoint a nominee to represent them in any dispute resolution process.
